The following conditions will apply in accordance with Florida Statute 715.07, City of Jacksonville Code 804.1301, and The Jacksonville Sheriff rules and regulation during towing of vehicles from the above mention property.

1. Vehicles will be towed only at the authorization of the property owner or their authorize representative. The duration of this agreement will be in effect until either party cancel the agreement. Towing is authorized 24 hours a day, seven days a week, at the call of the property owner or their authorize representative.
2. The rebate or payment of money to the property owner by Adkison Towing is prohibited in accordance with par (2)(a)4. of Florida Statute 715.07. No fees will be paid by the property owner. The vehicle owner/operator will pay fees in accordance with the rates establish by the Florida State Law.
3. All vehicles will be stored at Adkison Towing Company and within 10 miles of the point of removal in accordance with par (2)(a)1.a. of Florida Statute 715.07.
4. If the registered owner arrives at the scene prior to removal or towing of the vehicle, the vehicle will be disconnected from the tow truck and the owner will allowed to remove the vehicle, without interference, upon the payment of a reasonable service fee of not more than one-half of the posted rate. Adkison Towing Company must wait a minimum of 30 minutes to allow the vehicle's owner to secure cash for the payment of the fees.
5. Adkison Towing has the responsibility to notify the Jacksonville Sheriff's Office within 30 minutes of completion of such towing in accordance with par (2)(a)2. of Florida Statute 715.07.
6. Adkison Towing has the responsibility to carry general liability, on-hook liability, worker's compensation and employers' liability insurance.
7. The property owner or his authorize representative is responsible that the proper notice is posted in accordance with par (2)(a)5. of Florida Statute 715.07.
8. Adkison Towing has the responsibility to insure compliance with all of Florida Statute 715.07 after the vehicle is removed from the property.
9. The following personnel are the only representatives who are authorize to sign a towing authorization from at time of removal from the above mention company.
10. The contract can be cancelled by either party at any time and for any reason.
11. The property owner is not Liable for any damages done by Adkison Towing
12. Rates for towing are listed on the back of this contract. Rates may change annually as reviewed by City Council.
